MODERN SLAVERY STATEMENT

OUR BUSINESS

Our principal activity is providing trade waste services and skip hire to a range of customers.

OUR SUPPLY CHAINS

CSH Environmental limited take care to ensure that all their suppliers have taken the necessary steps to ensure that modern slavery or human trafficking is not taking place within their business or their suppliers.

We operate a supplier policy and maintain a preferred supplier list. We conduct due diligence on all suppliers before allowing them to become a preferred supplier. This due diligence includes an online search to ensure that organisation has never been convicted of offenses relating to modern slavery and child labour.

We audit our suppliers yearly to ensure they have the correct policies and procedures in place to ensure that no slavery or human trafficking is taking place.

OUR POLICY ON SLAVERY AND HUMAN TRAFFICKING

We are committed to ensuring that there is no modern slavery or human trafficking in our supply chains or in any part of our business. The purpose behind creating this Policy is to reflect our commitment to acting ethically and with integrity in all our business relationships and to implementing and enforcing effective systems and controls to ensure slavery and human trafficking is not taking place any where in our supply chains.

- Identify and assess potential risk areas in our supply chains.
- Mitigate the risk of slavery and human trafficking occurring in our supply chains.

TRAINING
